

Kiwi Truck Tyres: Terms and Conditions of Competition

USE OF A MUSTANG FOR 12 MONTHS PROMOTION TERMS & CONDITIONS

1. PROMOTION SUMMARY

- 1.1. The Kiwi Truck Tyres Giveaway allows the entrants to enter a draw to win the use of 2017 Ford Mustang GTV8 for 12 months.

2. HOW TO ENTER

- 2.1. Participants can enter as many times as they wish with a confirmed purchase of a Kiwi Truck Tyre.
- 2.2. Participants must report to the Kiwi Truck Tyres within 24 hrs. after being contacted by competition officials or their participation in the promotion will be forfeit.

3. THE PRIZE

- 3.1. The Winner will be selected, advised and confirmed in person on the day.
- 3.2. The Judge is appointed by Kiwi Truck Tyres Ltd and overseen by members of the New Zealand Police Force.
- 3.3. The prize consists of the use of the Ford Mustang for 12 months for the “*tyre end user*” and 3 months for the “*fleet service provider*”. The “*fleet service provider*” will have their company logo and contact details placed on the vehicle and joint promotion of their company for the 15 months.
 - 3.3.1. 2017 Ford Mustang GTV8 as promoted.
 - 3.3.2. The car has been used for promotional purposes so has therefore been driven and is not in an office showroom state.
 - 3.3.3. The Winner will be responsible for all other expenses related to the prize i.e. taxes, servicing, consumables, insurance excess etc.
 - 3.3.4. The prize will be collected from the Kiwi Truck Tyres Ltd office at 40 Firth Street Drury.
 - 3.3.5. The prize is non-transferable by the winner.

4. THE RULES

- 4.1. Each purchase of a Kiwi Truck Tyres tyre will receive a chance (entrance) into the competition during the period of 8am 1st February 2017 till 5pm 31st March 2017. (For benefit of clarity: 10 Kiwi Truck Tyres purchased will receive 10 chances to enter the draw.)
- 4.2. The “*end user*” of the Kiwi Truck Tyre will get the use of the Ford Mustang for a period of 12 calendar months from the date of the draw. The “*fleet service provider*” will receive their company logo and contact details placed onto the Ford Mustang for a period of 15 calendar months and use of the Ford Mustang for 3 calendar months on completion of “*end users*” 12 months.

- 4.3. Where the “*end user*” fits their own tyres they will receive the Ford Mustang for the period of 12 calendar months only.
- 4.4. The “*end user*” and “*fleet service provider*” will be publically declared the winner and a presentation made to acknowledge them as the official prize winner/s.
- 4.5. The Ford Mustang will be fully serviced using the manufactures recommended schedule
- 4.6. The Ford Mustangs Kiwi Truck Tyres logo, kiwi device, contact details and K1W1TT licence plate will not be removed, defaced or interfered with under any circumstances.
- 4.7. The Ford Mustangs “*fleet service provider*” logo device/s, contact details will not be removed, defaced or interfered with under any circumstances.

5. FURTHER COMPETITION RULES

Definitions

The '*Promoter*' is Kiwi Truck Tyres Ltd.

'Disqualified Participants' are: anyone who is without a full New Zealand Drivers licence, a conviction for Driving Under the influence of Alcohol or Drugs, a conviction for Dangerous Driving, or who is under the age of 25.

All Jones Trading Group employees, principals and/or senior management of participating sponsors or promoters and/or advertising agencies, sub-contractors or any other person that is working or volunteering for Jones Trading Group and their Immediate Families;

'Immediate Families' include spouses, Grandparents, Parents, Children, and Grandchildren whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extension.

'The Winner' is defined as the person whose is declared The Winner as per '*THE RULES*'.

5.1. Entry

- 5.1.1. Entry into the promotion is deemed to be acceptance of the Rules and confirmation that the entrant has the necessary authority to enter the promotion.
- 5.1.2. Disqualified Participants may not enter in the promotion.
- 5.1.3. Kiwi Truck Tyres Ltd reserves the right to exclude any person from participating in the promotion on reasonable grounds.
- 5.1.4. Kiwi Truck Tyres Ltd reserves the right to refuse to award any prize to an entrant who Kiwi Truck Tyres decides (in its sole discretion) has violated the Rules, gained unfair advantage in participating in the promotion or won using fraudulent means.
- 5.1.5. By participating, entrants grant Kiwi Truck Tyres Ltd exclusive permission to use their names, characters, photographs, videos, voices and likeness in connection with the promotion and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.

5.2. Winning the Prize

- 5.2.1. The Winner will be determined in the manner set out in the Specific Rules.
- 5.2.2. The Judge's determination of the Winner will be final and no correspondence will be entered into.
- 5.2.3. The Winner will be notified in person and must be available for the preparation of all publicity that may be required by Kiwi Truck Tyres Ltd.
- 5.2.4. The prize is not redeemable for cash or transferable. No other family members, friends, office associates or any other person will be able to participate on the Winner's behalf.
- 5.2.5. The Winner takes the prize entirely at his/her own risk and indemnifies Kiwi Truck Tyres Ltd. in respect of any claim for any accident, injury, property damage or loss of life that may occur in connection with the prize.

- 5.3.1. Kiwi Truck Tyres Ltd being the owner of vehicle at all times, will secure full coverage insurance for the Ford Mustang, listing the winner/s as the authorised driver/s.

- 5.3.3. Kiwi Truck Tyres Ltd takes no responsibility for any inability to enter, complete, continue or conclude the promotion due to equipment or technical malfunction, Acts of God or otherwise.
- 5.3.4. To the fullest extent permitted by law Kiwi Truck Tyres Ltd will not be liable for any loss or damage whatsoever (including but not limited to direct or consequential loss) or for personal injury as a result of promotion entry or winning the prize.
